Filing Period: 2/17 (Mon) - 3/17 (Mon)

Location: 1F Ginowan City Office (main entrance)

Who is required to file for municipal/prefectural resident tax?

- Any resident who had an address in Ginowan City as of January 1, 2025 and who had some kind of income last year (regardless of whether they were employed)
- Residents who had no income but would like to have their National Health Insurance or Nursing Care Insurance premiums reduced must file and declare their income as zero.
- Residents who only had a salary income or income from pension who would like to add dependents, add life and social insurance deductions, or medical expense deduction.

Documents required

- Tax declaration form (available at the location)
- My Number Card or My Number Notification card + photo ID

Additional documents (if required)

- Salaried employees and public pensioners: Withholding Tax Statement (in Japanese: gensen choshu-hyo)
- Business owners, real estate/property income earners: Statement of Earnings and Expenses
- National Health Insurance and Long-term Care insured person: proof (certificate) of premiums
- National pensioners: social insurance premium ryo kojo shomeisho)
- Individuals with disability: disability handbook
- Students: student ID
- Individuals claiming for medical deduction: breakdown of medical expenses incurred last year and relevant receipts

What happens if I do not file my taxes?

You may find yourself unable to get tax-related certificates issued or become unable to receive a reduction in National Health Insurance and Nursing Care Insurance premiums.

Why do I need to file my taxes?

H Y It is so that the city can calculate all your income and determine a fair and appropriate municipal/prefectural tax amount based on your income.

However, if you only had a salary income and have already completed the year-end tax adjustment, only had income from public pension, or are a dependent of a Ginowan resident who has already completed the year-end tax adjustment or final income tax return, you do not have to file for resident tax.

deduction certificate (in Japanese: shakai hoken- Note 1: If you have already filed your income tax return, you do not need to file city/prefectural taxes and national health insurance taxes. Note 2: From November 2025, dependents who have not filed will no longer be able to obtain tax certificates at convenience stores, etc., using their My Number card.

Additional Applications Being Accepted for School Assistance Program in 2025



School assistance program helps with assistance for school supplies and school lunches for families with elementary and junior high school children.

Applications for 2025 ended in August 2024, but additional applications are now being accepted for households that have not yet applied.

Eligibility

- 1. Those who have not applied for school assistance in 2025.
- 2. Children born between April 2, 2010, and April 1, 2019.
- * You do not need to apply again if you have already applied at the City Hall in August 2024.
 - Application Period: 2/3 (Mon) to 2/17 (Mon)
 8:30-11:45, 13:00-17:00
 - Where to Apply: Board of Education Student Affairs Division (2nd Floor of Waterworks Bureau)
- Application forms are available at your child's elementary or junior high school or at the Board of Education.
