## Automatic Certificate Issuing Machines to be discontinued in March 31<sup>st</sup> 2019



Convenience Store Certificate Issuance services, the automatic certificate issuing machines available at the City Hall, Library and Museum will be discontinued in March 31<sup>st</sup> 2019.



#### Regarding the use of the Ginowan Card (inkan registration)

Please do not discard or lose your "Ginowan Card (inkan registration", or your "inkan registration", as they will remain necessary in order to get an inkan registration certificate issued at the counter.

### You can obtain certificates issued by the city at convenience stores!

The "Convenience Store Certificate Issuance" services are available in Ginowan City, which allows you to obtain certificates (such as the Certificate of Residence, Inkan Registration Certificate, copy of Koseki-no Fuhyo, Koseki Shohon and Certificate of Taxable Income) outside service counter opening hours or during holidays. Through these services, you can obtain certificates with a My Number card (equipped with a "user electronic certificate"), using a kiosk terminal (multi-copy machine) available in convenience stores across Japan. Take this opportunity to consider getting a My Number card!

#### Delivery of Vouchers for the 2019 Silver Passport

Ginowan City has implemented the "Ginowan City Silver Passport Project" to encourage people over 65 to enjoy a fulfilling live and increase their opportunities to go out more. Residents over 65 may get the "Silver Passport Card", and people over 75 are issued vouchers<sup>®</sup> that can be used at participating facilities. <sup>®</sup> vouchers… You may use one ticket (500 yen) every month at about 80 participating facilities which promotes health such as pharmacies, beauty parlor, massage, taxi... (a list of the participating facilities is provided with the vouchers).

Vouchers for 2019 will be delivered starting April 1<sup>st</sup>. Vouchers will also be available at community centers.

#### 2019 Application for National Pension's Special Payment for Students!

People over 20 years of age, including students, must enroll in the national pension system and pay contributions. However, if you have low income and have difficulty paying contributions, you may apply for the "Special Payment for Students".

**Eligibility**: Students enrolled in an institution designated by the Ministry of Health, Labor and Welfare; university (graduate school), junior college, high school, vocational school, or other types of schools

Regional employment counseling Mon~Fri 9:30~17:00 2893-5588 Income standard: The income of the applicant is of less than 1,180,000 yen for the previous fiscal year, in addition to 380,000 yen per number of dependents+social insurance premium deductions, etc.

**Necessary documents**: ①student ID (Copy is OK) or Certificate of Student Registration/of Attendance(original) ②Inkan seal (personal seal "mitome-in" is OK: self-inking rubber stamps "shachihata" not approved)

Application period: from April 1st onwards

■ The contributions under the special payment system is counted towards the contribution period (at least 10 years) for your future Old-Age Pension. ■ The period will not be considered when calculating the amount of pension, however, premiums can be paid retroactively for up to 10 years in order to avoid reduction of pension. If you pay premiums after the third year, from the year after the approval for the exemption period was obtained, the additional amount corresponding to the elapsed period will be added to the amount of premium at the time when approval was obtained. ■ When claiming the Disability Basic pension, the exemption system it is treated the same as during payments. (Please note that your request may not be granted if the application for the Special Payment System for Students is delayed.)

#### Tax Collection for the End of the Fiscal Year

#### Did you forget any City Tax payments?

Please pay by the due date to prevent arrears. We offer tax payment consultation if circumstances prevent you from being able to pay: please contact us if necessary.

How long does it take before my property is seized?

①Due date passes = tax payment now in arrears, mailing of a reminder notice

A reminder notice is sent within 20 days after the payment due date.

#### ②Seizure of property

If the payment is not completed within 10 days following the issuance of the reminder notice, property is subject to seizure.

Seizing procedures may begin as quickly as 1 month after the payment due date!
