Medical Expense Deduction Certificate for Diaper Expenses

For those who are receiving nursing care and who have been filing medical expenses deductions for diaper expenses on their income and resident tax declarations for at least one year can replace the *Omutsu shiyō shōmeisho* (certificate proving usage of diapers) with a certificate issued by Ginowan City Hall.

Requirements (must fulfill all of the below):

- Those who have been declaring taxes for diaper expenses for at least one year.
 Those on their first year will need an *Omutsu shiyō shōmeisho* (certificate proving usage of diapers) from a physician.
- Have a statement from primary physician written in the same year as the period of diaper usage.
 Expiration date of the current certification for long-term nursing care is over 13 months away.
 In the case that there was no statement from primary physician written in the year of the period of diaper usage, a statement from the last two years may also be accepted.
- 3. Those who can prove with a primary physician's statement that he or she is/was bedridden (level B1 C2) and suffered a risk of urinary incontinence.

Applications can be made at the Nursing Care and Longevity Division (*kaigo chōju-ka*). Certificates are ¥300 per copy. Please bring applicant's *inkan* (name stamp) and a piece of ID.

Eligibility for Disability Deduction Certificate

Those over 65 years of age who are receiving nursing care or nursing support and who do not have a disability book (障害者手帳 *shōgaisha techō*) may be issued a "Certificate of Eligibility for Disability Deductions". The certificate can be used to apply for city/prefectural resident tax or income tax deductions.

Eligibility (must fulfill all of the below):

- Over 65 years of age,
- Receiving nursing care or nursing support, and
- Do not have a physical disability book (身体障害者手帳 shintai shōgaisha techō), intellectual disability book (療育手帳 ryōiku techō), or psychological disability book (精神障害者保健福祉手 帳 seishin shōgaisha hoken fukushi techō) as of December 31st* of the year previous.

*for those deceased, it will be as of the date of death.

Type of Deductions:

1. Disability Deduction:

The degree self-sufficiency of the elderly person with disability is level A, and for those with dementia is II (as determined by the primary physician's statement).

 Special Disability Deduction: The degree of self-sufficiency of the elderly person with disability is

level B or C, and for those with dementia is III, IV, or M (as determined by the primary physician's statement).

Applications can be made at Nursing Care and Longevity Division (*kaigo chōju-ka*). If applying on behalf of a family member, a letter of agreement written by the person in question is required. Applications need to be renewed every year.
