**We'll let you know when your COVID-19 vaccine is ready for you.** Not all clinics have English-speaking staff. Please confirm with the individual clinics ahead of time to see if you will be able to receive the vaccine there.

### How to book a COVID-19 vaccine appointment

1. Through the city's website (scan QR code) 
2. By calling the **Ginowan City Call Centre** at **050-5526-1940**.



### When booking, you will need your vaccination voucher number.

Mass vaccination takes place every Wednesday afternoon, and on Thursdays and Sundays. **Bookings are only accepted through the city's website and the Ginowan City Call Centre.** Your appointment may be cancelled in the event of a typhoon or other severe weather phenomenon.

# National Health Insurance premium payments begin in July

NHI premium payments are broken up into 8 to 9 payments to be paid throughout the year beginning in July every year

NHI premiums are broken up into **eight** payments, and NHI for People 75 Years of Age and Above are broken up into **nine** payments to be paid throughout the year beginning in July.

Methods of payment including paying at convenience stores, designated financial institutions. If payment is not received by the due date, you will be charged a late fee and a fee for the demand procedure.

## Preauthorized debit

You can set up preauthorized debit (automatically deduct from bank account). You only need to sign up for preauthorized debit once to continue using this service for future years.

## If you have difficulty making payments, consult with us!

Please consult with us anytime if you have difficulty making payments due to unavoidable circumstances such as:

- ① An illness or injury severely impacting daily life
- ② Financial difficulty resulting from a job loss
- ③ Suffering significant losses due to the suspension of business
- ④ Your housing is damaged due to natural disasters

## If you are affected by the COVID-19 outbreak...

If you are experiencing difficulty making payments due to the effects of the COVID-19 outbreak, you may be eligible to apply for a reduction or postponement of payments.

Those who have not been paid their salary due to not being able to work as a result of contracting COVID-19, or being suspected of contracting COVID-19 may be eligible to receive the Sickness and Injury Benefit.

## Have you filed your 2020 income yet?

If you have not yet filed your taxes for 2020, you may be in a disadvantageous position when applying for a reduction in premiums, or the High-Cost Medical Care Benefits in the case of hospitalization, etc.

# National Pension Exemption Application for fiscal year 2021 opens in July

Monthly contributions for fiscal year 2021 (April 2021 to March 2022) is ¥16,610

If you, your spouse, or the head of household's income from the previous year (or income from two years ago if you apply for exemption between January to June) is below a certain amount, you may be eligible to apply for an exemption of National Pension contributions. This also includes those who lost a job or are suffering losses due to disasters. Students are eligible for a special exemption.

If approved, you may be eligible to receive **full** or **partial** exemption.

You may also apply for exemption for the period backdating two years and one month.

**A special measure to support those having difficulty making contributions due to the effects of the COVID-19 pandemic is available.**

## Eligible exemption period:

- exemption fiscal year 2019 (February - June 2020)

- exemption fiscal year 2020 (July 2020 - March 2021)

- exemption fiscal year 2021 (July 2021 - June 2022)
