## Subsidy for Preschool Education

## For unlicensed nurseries and kindergarten afterschool daycare service

A subsidy for preschool education is available for children using unlicensed nurseries, kindergarten afterschool daycare service, temporary childcare programs, childcare programs for sick children, the Family Support Centre, and babysitters. If approved, you can claim back the cost for tuition and fees. Approval usually begins on the day that you submit your application. If you haven't already, please make an application as soon as possible. Those whose approval is set to expire will need to renew their application.

\*As a general rule, children attending kindergarten or certified centres for early childhood education (Category I) who are also using other facilities will not be eligible to get coverage for the use of such facilities.

#### [Eligibility Criteria]

- 1. Category II (children over 3 Y.O. as of April 1, 2022)
  - Parents must have a valid reason for needing childcare services (such as being employed for over 64 hours a month, is pregnant or have just given birth, or has a disability or illness, etc.)
- 2. Category III (children under 2 Y.O. as of April 1, 2022)
  - In addition to the condition stated above, the parents (or legal guardian) are exempt from paying residence tax
- \*Approvals prior to August 2022 will be granted based on the applicant's residence tax status from FY2021, while approvals in September 2022 onward will be granted based on residence tax status from FY2022. As a result, those who had not been previously eligible may become eligible, while those who had been eligible may become ineligible to receive coverage.

#### Tuition Coverage for Single Parent Families Using Unlicensed Nurseries

Single parent families that were unable to enroll their child in a public nursery due to a lack of openings and whose child is currently attending a private (non-registered) nursery are eligible to get tuition coverage.

#### [Eligibility]

- ①Must have a registered address in Ginowan City
- ② Is a recipient of the Childrearing Allowance for Single Parent Families or the Single Parent Medical Expense Coverage
- 3 Have applied for a public nursery but is currently being waitlisted\*
- ④ The non-licensed nursery that the child is attending has submitted a notification of business to the prefecture

#### [Amount Covered]

The difference between the tuition for the unlicensed nursery and a public nursery will be covered. The maximum tuition amount that can be covered is 33,000 yen. For example:

Will be given the Tuition for Equivalent tuition for a unlicensed nursery licensed/public nursery\*\* maximum coverage 37,500 yen → amount of 7,500 yen 45,000 yen 33,000 yen

#### [Lunch fees]

The total monthly cost for school lunches or the maximum coverage amount of 5,000 yen, whichever is lower, will be covered.\*\*\*

- \*Families who were offered a spot in a public daycare but who turned down the offer will have their eligibility revoked at the end of the month on which the offer was made.
- \*\*The equivalent tuition fee for a licensed/public nursery differs depending on household income level.
- \*\*\*Households who are receiving the Subsidy for Preschool Education are only eligible to receive coverage for school meals under this scheme.

### Special Cash Handout for Low-Income Families with Children

Excluding low-income single parent families\*

A special cash handout of 50,000 yen per child is available to low-income families with children. Families that that are not required to submit an application have been notified by mail in late July.

#### Do I need to make an application?

You must submit and application if you have children who are under 18 years of age (or 20 years of age for children with disability) as of March 31, 2022 and meet any one of the following:

- ① Belong to a household that is not taxed a per capita levy for resident tax (\*those who have no done so must file their taxes)
- ② Belong to a household that was affected by the COVID-19 pandemic and experienced changes in household finances who are recognized to have the same circumstances as those exempt from resident tax on a per capita levy rate

#### ■ How much is the handout and when is the application deadline?

The handout is 50,000 yen per eligible child. The application deadline is February 28, 2023. You will lose your eligibility to receive the handout if your application is late. Please note that households that have already received a handout for single parent families will not be eligible to receive this handout.

#### ■ When will the payment be paid out?

Around the end of the month following the month of application (ex. applied in August → payment should be disbursed at the end of September)

#### OTHER ANNOUNCEMENTS



Category I insured persons under the National Pension System are eligible to receive exemption for a certain period before and after childbirth. For more information, please visit the Pension Division at the city office. \*Childbirth is defined as a pregnancy that lasts over 85 days and includes stillbirths, premature births, miscarriage, and abortions.
