FY2023 NATIONAL HEALTH INSURANCE & MEDICAL SYSTEM FOR THE ADVANCED ELDERLY PREMIUM PAYMENTS BEGIN IN JULY

Fiscal year is from April 1 to March 31

FY2023 National Health Insurance payments are broken into 8 payments to be paid between July and February. Payment for the Medical System for the Advanced Elderly is broken into 9 payments to be paid between July and March.

Payments can be made at any convenience store nationwide, selected financial institutions or electronically using the payment slips mailed to you. Please note that convenience stores and electronic payment systems can only process payment slips that are printed with a bar code. A processing fee and a late fee will be charged if payment is not made by the deadline. If you have difficulty making payment, please consult with us as soon as possible.

*REGISTER FOR PREAUTHORIZED DEBIT!

You can register your bank account with the city office and have the premiums deducted automatically so you will never miss a payment. You only need to register once - your information will be carried over to the next fiscal year.

HAVE YOU FILED FOR YOUR 2022 INCOME?

Not filing your taxes may affect your eligibility to receive a reduction. It may also affect the calculation of your base amount (maximum amount of out-of-pocket fees) for hospitalization and high medical expenses.

FY2023 CERVICAL CANCER AND BREAST CANCER SCREENING

Screening vouchers are being sent out to eligible residents

Eligible residents that have received their vouchers can get screened any time between now and January 31, 2024.

| Screening | Eligibility (age as of 31/03/2024) |

| Cervical cancer | Women over 20 year of age who did not get screened for cervical cancer in the last fiscal year |
| Breast cancer | Women over 40 years of age who did not get screened for breast cancer in the last fiscal year |

BOX JELLYFISH ALERT:

FY2023 NATIONAL PENSION APPLICATION FOR EXEMPTION BEGINS IN JULY

The FY2023 monthly premium is 16,520 yen

If you, the head of household, or your spouse's income from last year is below a certain amount (670,000 yen threshold for single-person households) or if you are experiencing unemployment or suffering financial loss from a natural disaster that is making it difficult for you to make payment, you can apply for a full or partial (three quarters, half or one quarter) exemption at the Pension Unit on the main floor of the city office.

Exemption applications are assessed by the Japan Pension Service. An application can be made retroactively for the period dating back 2 years and 1 month from the date of application.

*Students applying for the Special Exemption for Students must provide their student ID and a proof of enrollment.

- If you leave your premiums unpaid...
 - 1. It may affect your eligibility to receive Old Age Pension in the future
 - 2. It may affect your eligibility to receive Disability Pension or Pension for the Bereaved should you be affected by a death or disability
- When you are approved for an exemption
- The period of exemption counts towards your contribution period (10 years). However, the amount of pension you receive may be less than if you had made full amount of contributions for Old Age Pension.
- For Disability Pension and Pension for the Bereaved, the period of exemption is considered the period of contributions paid.
- *The period of deferment of payment and Special Exemption for Students will not be reflected in the amount of pension payments received.
- *If you are approved for partial exemption but fail to make payment, you will be considered to be in arrears.

■ Recovery of past contribution-exempt periods

If you had exemptions in the past, you can recover the period of exemption by paying the exempted contributions retroactively for up to 10 years. Please note, however, that a charge will be added to contribution amount on the third year onward from the year following the period of exemption.
