
#### **Effects on Terrestrial Digital Broadcasting (TV signal)**

There have been many complaints from residents all over Ginowan City regarding the aircrafts' interception of TV signals (Terrestrial Digital Broadcasting) causing temporary loss of signal every time an aircraft flies over a residence. Upon requesting assistance from the Government of Japan, the Okinawa Defense Bureau has approved for certain parts of the city (Nodake, Futenma, Aragusuku) to obtain funded remediation work. However, the city still receives complaints from residents living in parts of the city excluded from funding. The city is continuously seeking solutions to solve the issue.
